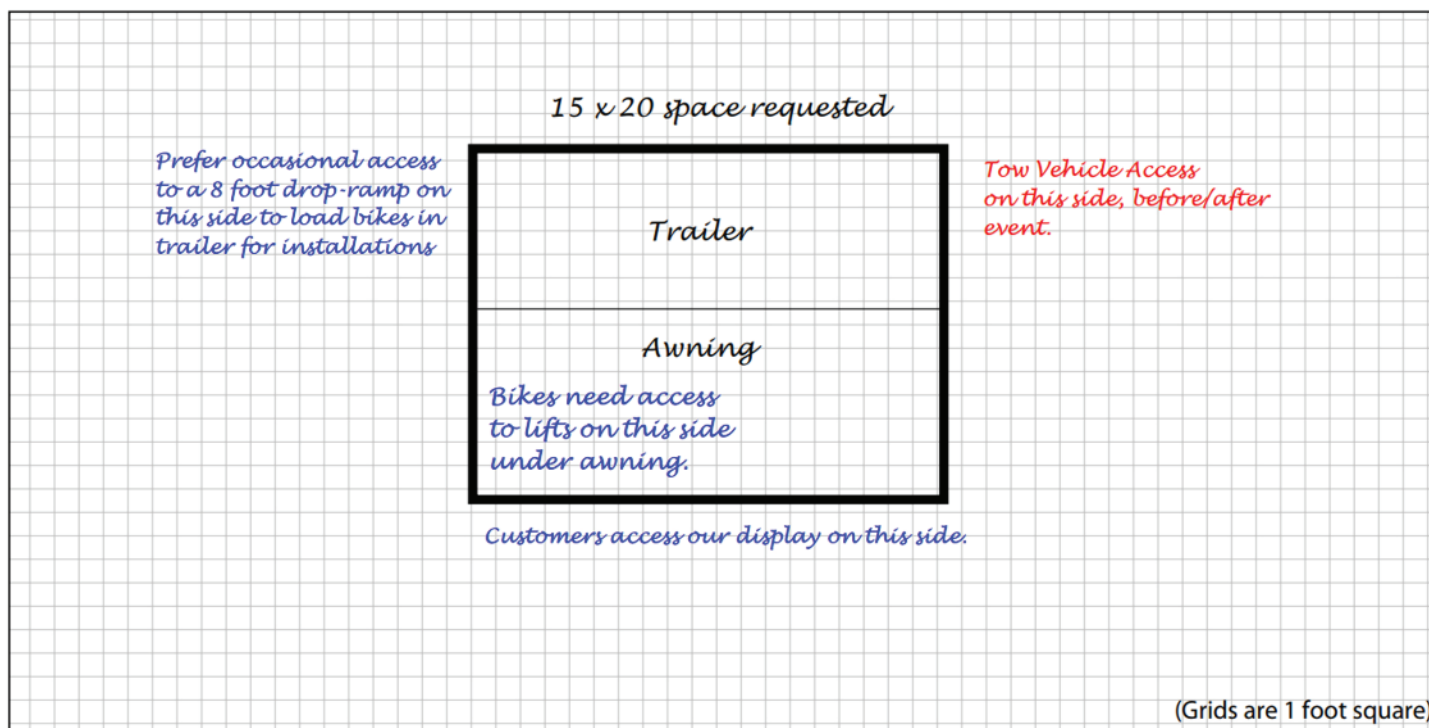
UNSUITABLE ITEMS AND/OR ACTIVITY

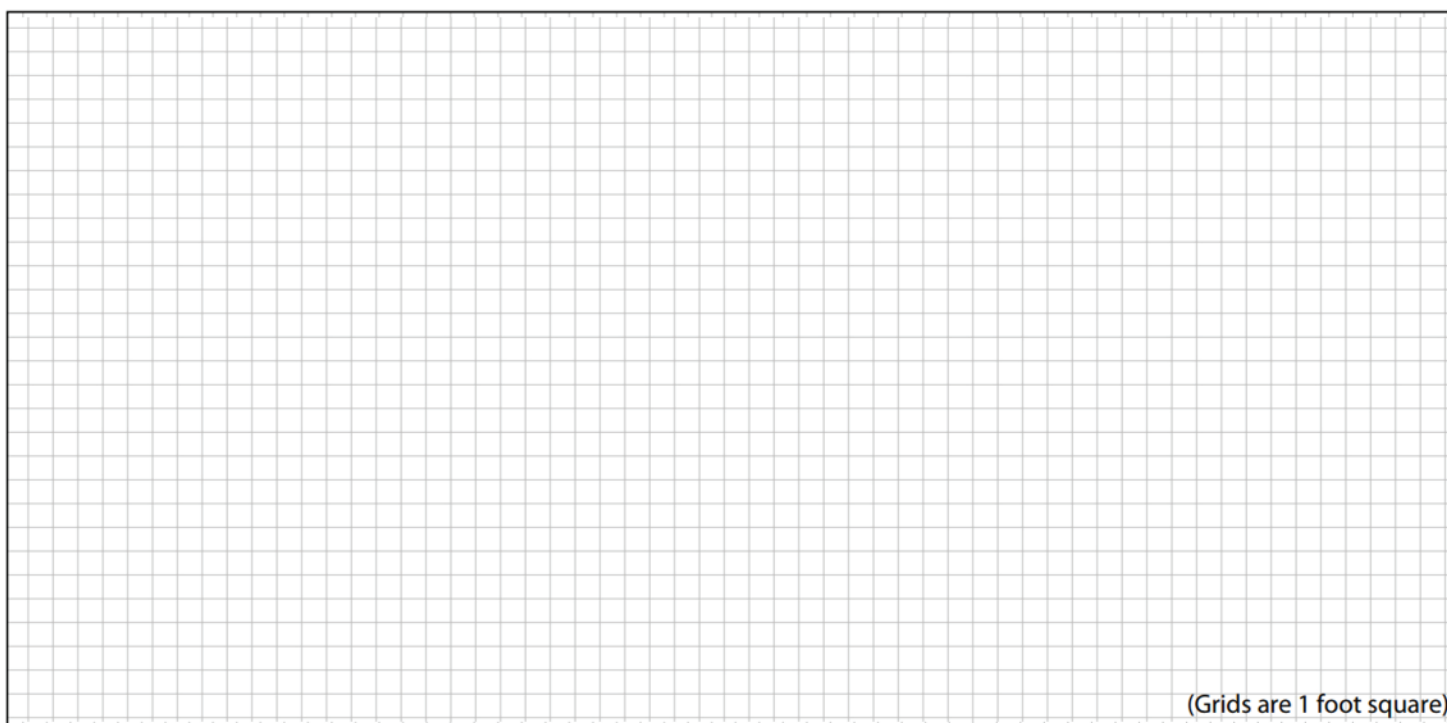
ALL RULES WILL BE STRICTLY ENFORCED

To best assist you in placing your exhibit or display to your best advantage while vending for our event, please indicate on the grid-form below what your final footprint would look like, indicating which side(s) require open access to customers, where ride-in access would be needed if bikes need to enter your space for installation or custom work, which sides you might prefer to have hidden from customer access, and especially which sides might need access to your tow vehicle while placing your trailer in the assigned space. **For Example:**

We will make every effort to try to accommodate you, but be aware if your requests limit our ability to place other vendors nearby, you may be required to increase your vending space. Be aware that signs, displays, bikes, racks or tables may NOT be placed in front of your assigned space unless you have reserved that space for your vending activities.

Vendor hereby agrees to indemnify, save and hold harmless the Releasees and each of them from and against any loss, liability, damage, or cost Releasees may incur from any and all claims, demands, actions, causes of action, penalties, judgments, and liabilities of every kind and description (including court costs and reasonable attorney fees) for injury to or death of any persons, and damage to and loss of property which are caused by, arise from or grow from acts or omissions of vendor incident to Tobacco Road H-D or from any breach by vendor of any term or condition of this agreement. Vendor Guidelines

Tobacco Road Harley-Davidson welcomes you to one of our South Saunders Street location events. The following outlines instructions regarding payment, load-in, rules and regulations for the event.

Please read carefully as some details have changed from previous events.

Vendors with whom **payments received later than 2 weeks prior** to the event will be evaluated and run the risk of not being included in the event. Vendors are assigned to the better spots when payment/contract is received early. No assignment until payment is made.

Load-In: Upon arrival at the dealership please check in with staff onsite, or at the Vendor Check-in located inside the dealership at the reception desk. Vendors should plan to arrive between the hours of 8am through 8:30am for Saturday events to begin setup. Vehicles should be removed from the Vendor area by 9am Saturday. Earlier setup is by prior approval and coordination ONLY.

Dealership Event hours are typically 9am to 5pm - please check with us for the exact event times for the event you apply for.

It is imperative to come to the vendor check-in first before entering the footprint of the event. Vendors will be provided with their booth number and parking assignment upon check-in. You will be escorted by event staff to your vendor location.

Vendor Vehicle Parking: Once you have unloaded you should move your vehicle to the assigned parking lot. You may continue setting up your booth after you have moved your vehicle to the specified lot.

Event staff will be on duty to ensure all questions and concerns will be addressed. Remember to be patient. There are many elements (vendors, stages, displays and often large trucks), which will be setting up in the same area. Please be cautious and expeditious in setting up your booth. If you need electricity, please discuss well in advance with us. Availability is limited.

Rules and Regulations:

- Vendor booths must remain within your assigned space, to allow for motorcycle parking in the street in some cases. Noncompliance with event staff will be subject to dismissal from the event with no refund.
- The approved vendor will occupy his/her booth at all times. No subletting or sharing of space is permitted.
- Each vendor is responsible for collecting NC State Sales Tax and filing the necessary paperwork with the NC Department of Revenue.
- An accepted application is a commitment to display your work/services during ALL scheduled hours of the event. No refunds will be issued for cancellations.
- Exhibitors should use their own means of display, sufficiently sturdy to withstand weather and crowds. Staking into pavement or concrete will not be allowed. Each exhibitor is responsible for his/her own display in case of loss or damage. Sufficient buffer between vendors should be provided.
- **ALL WORK DISPLAY AND STORAGE WILL NOT GO BEYOND THE ASSIGNED EXHIBITOR SPACE.** Your booth should not interfere with your neighbor's booth. Do not expand your space after the event starts, as some Vendors may arrive in specified spaces later.
- Exhibitors should be timely in arrival and expedite setup in as quick a manner as possible. All vehicles must be removed from the event site at specified times.
- Set-up and breakdown times will be strictly enforced. You must arrive at the specified time. Breakdown will not begin until the end of event. Vehicles will not be permitted into the event area until all visitors have left the area.
- All waste materials are to be disposed of properly, either in on-site trash receptacles, or removed by each exhibitor to be disposed of off-site.
- You cannot sell Harley-Davidson® or Triumph branded merchandise without prior approval by event management.
- Tobacco Road H-D cannot supply change for your ride or vendor booth. Please bring an adequate amount of change needed for your customers. Thank you.
